Application for A Registrar-General’s Special Licence

The Law of Marriage Act, 1971, Section 23

NOTE: -(1) To be completed in original and submitted to the Registrar-General of Marriages (2) A fee of Shs. Must accompany the application; fee is not refundable

HEREBY APPLY for the grant of a Registrar-General’s Special Licence and SOLEMNLY AND SINCERELY DECLARE:

- (1) that the particulars stated above are true; (2) that my intended wife/husband and I are not related within the prohibited relationship (3) that there is no lawful impediment to the proposed marriage; (4) that the consent of (full name of person consenting and his or her relationship to the party under age to the proposed marriage has been obtained and is annexed hereto and marked “A”. (5) that I now ask the Registrar-General of Marriages to dispense with the giving of notice for the following reasons (state the reason why notice has not already been given and why the parties do not wish to give one now):

AND I make this declaration conscientiously believing the same to be true and in accordance with the provisions of the Oaths (Judicial Proceedings) and Statutory Declaration Act, 1966.
